*Make change, restock items and cleanup at the end of day


*Work shifts of 2 to 3 hours

What Do Field Maintenance Volunteers Do?

*Gator the infields so water drains off the fields after rainfall *Drag and rake the infield to fill in ruts and puddles *Identify and remedy safety hazards in the outfields *Maintain & repairs structures around the fields including fences, dugouts, bleachers, and storage sheds *Ensure that running paths are level *Ensure that pitcher's mounds and home plate areas are in playable condition and conform to league requirements

What Do Coaches and Assistant Coaches Do?

*Arrange and conduct weekly practices and games *Prepare playing fields before each game and ensure clean up after *Show an understanding of baseball knowledge including little league rules *Teach basic baseball skills such as batting, catching, throwing, & pitching *Conduct fundamental drills to warm players up before each game *Model patience, understanding, & how to play fair and be a good sport *Model positive attitude centered on having fun and not just focused on winning *Communicate with parents on a regular basis through apps, email & meetings *Attend coaches' meetings and workshops *Plan team uniforms and work with team mom to order and distribute *Bring necessary equipment to each game and practice
